

Getting to the MaRS Centre: Directions & Accessibility

The MaRS Centre is easily accessible by major modes of transportation, with direct access to public transportation.

PUBLIC TRANSPORTATION – TTC



SUBWAY:
Line 1 to Queen's Park Station



STREETCAR:
The eastbound and westbound 506 Carlton streetcar stops directly outside MaRS at the intersections of College Street and University Avenue, as well as College Street and Elizabeth Street.

DRIVING AND PARKING

Underground parking is available at the MaRS Centre at a cost of \$8 per hour, to a daily maximum of \$20.00 (until 10pm). During evening and weekends: \$8.00 evening max (until 8am), \$8.00 Weekend day max (5am-5am).

The MaRS Centre underground lot can be accessed via Elizabeth St. or University Avenue. Additional parking is available at a host of parking garages and above ground lots within a two-block radius.



ACCESSIBILITY

The MaRS Centre supports the full inclusion of persons with disabilities as set out in the Canadian Charter of Rights and Freedoms, Ontario Human Rights Code, the 2001 Ontarians with Disabilities Act (ODA) and the 2005 Accessibility for Ontarians with Disabilities Act (AODA). MaRS will make reasonable efforts and use all means at its disposal to ensure that the information or service requested is provided in a manner that is consistent with the principles of independence, dignity and equality. SERVICE ANIMALS

Service animals, including guide dogs, are permitted on the premises. Documentation from a regulated health professional confirming the necessity of the service animal may be requested and must be presented upon request. It's important to note that emotional support animals do not qualify as service animals under the AODA. In cases where it is not obvious that an animal is a service animal, MaRS Centre staff may ask for documentation confirming the prescription for the service animal. The owner of the service animal is responsible for the animal's behaviour while on the premises. This includes attending to the animal's needs and cleaning up after it. If a service animal is causing a disturbance to other visitors, the visitor and their service animal may be asked to leave the area. Animal relief areas are accessible in the parkette located at 200 Elizabeth St (outside of the East doors of MaRS).
